Based on that information, the board determined to recommend remaining with SDP. A listing of ideas for questions was discussed and PattiP. accepted the action to prepare the questionnaire and mail it to all chapter members with a post-paid return envelope. She will compile the results and have it available for the next Executive Board meeting.
